CHARITY GIFT AID

Gift Aid is claimed by The Arts Society from the tax you pay in the current year. In order for your donations to qualify for Gift Aid you must be a UK taxpayer. If you pay Income Tax at the higher rate and want to receive the additional tax relief due to you, you must include all your Gift Aid donations on your Self-Assessment tax return or ask H.M Revenue and Customs to adjust your tax code.

If you are a higher rate taxpayer, you are a higher rate taxpayer, you can also claim back the difference between the standard and higher rates of tax in your Self-Assessment tax return.
